The Managing Council of the MOGS hereby invites nominations from eligible members of the Society to contest the election to the Managing Council for the year 2021-2022 for the post of Second Vice President (1 post), Treasurer (1 post), Joint Clinical Secretary (1 post) and for the 7 members for the Managing Council for 3 years and for any other posts that may fall vacant before the election.

The nomination must be submitted in the accompanying form, duly proposed and seconded and the duly completed nomination should be submitted to the Society's office. Nominations will be received in a sealed box at the office of MOGS from Monday to Friday between 12.00 noon to 5.00 pm and on Saturday between 12.00 noon to 2.30 pm. Nominations will be accepted till **5.00 pm on Tuesday, 30 March, 2021** at which time the box will be opened to scrutinize and record the nominations. The candidates may check the list of nominations at that time.

Formal requests for withdrawal of nominations must be submitted in writing to the Society's office by **5.00 pm on Wednesday, 07<sup>th</sup> April, 2021**.

An individual member may submit nominations for more than one post, but will be permitted to contest for any one post by withdrawing other nominations. Attempting to contest for more than one post will render all the nominations ineligible for the election. Any member joining the MOGS within four weeks of the Annual General Body Meeting of the Society shall not be eligible to vote at that Annual General Body Meeting, Any member whose subscription is in arrears will not be eligible for election to the Managing Council, is ineligible to propose or to second a nomination for election and will not be permitted to vote.


