Dear Madam,

We are in receipt of your letter dated 30<sup>th</sup> April 2024 addressed to the President of our Association of Medical Consultants Mumbai asking for help to your members in cases of threats of mob violence at their place of work. We would like to state that our Association has a tie up with a security agency called Jeevan Ambulance and Security service which promises to provide our members security help in the form of 2 security personnel reaching them in case of any medical emergency situation or a security threat from unruly patients or their relatives. This service is available free of cost to all our members who are part of our Professional Indemnity scheme. Our members who are not part of the Professional Indemnity scheme also receive the help immediately but they are requested to pay the agency predefined nominal service charges.

Since your members also practice in the geographical area where these services are provided, and a large number of your members are also our members they are entitled to the same service in any case. We would request you to ask any members of your organisation who are not yet members of AMC Professional indemnity scheme nor members of AMC should immediately become members of AMC and its Professional indemnity scheme so that they too can avail the services of this agency.
