Purpose of the prize: To recognize outstanding original work in the subject of the candidate's choice. (5 copies of thesis / paper and Biodata along with covering letter).

Eligibility and exclusion criteria:

- Should be MOGS member.
- Registration with Maharashtra Medical Council not more than 5 years on 1st January of the year in which the award is being given.
- Recommendation letter from Head of Institution/Department/Unit or postgraduate teacher.

- Well acquainted with the subject to be studied
- General knowledge about the country to be visited
- Recommendation letter from Head of Institution/Department/Unit or postgraduate teacher.
